





# NOTICE OF RACE NEW CALEDONIA GROUPAMA RACE

## **PREAMBLE**

New Caledonia Groupama Race is a 654NM sailing race around New Caledonia.

The start of New Caledonia Groupama Race, including all categories (open, double, and cruising), will take place on Sunday, June 9th, 2024.

The departure procedures will be provided in the race instructions and during the briefing.



### I. RULES

- **1.1** The rules as defined in The Racing Rules of Sailing.
- **1.2** World Sailing Offshore Special Regulations Category 3 with liferaft and with modifications and specific requirements by the Organizing Authority (OA).
- **1.3** I.R.C class rules, parts A, B, and C.
- 1.4 ORC Club class rules.
- 1.5 Offshore Multihull Rating (OMR) or Multi 2000 Rating rules.
- 1.6 Between sunset and sunrise, when a boat cannot determine with certainty which tack another boat is on, she must keep clear of that boat. Competitors are reminded that part of definition of "room" in the Racing Rules of Sailing includes taking into account the existing conditions (including visibility). Nothing in the Notice of Race or the Sailing Instructions relieves a boat of her responsibility under civil law to comply with the international Regulations for Preventing Collisions at Sea or local regulations.
- **1.7** Official Notice Board: Amendments to the notice of race will be posted on the event's website at <a href="https://www.groupamarace.nc">www.groupamarace.nc</a> and may be notified to competitors via email.
- **1.8** In case of conflict in translation, the French text shall prevail.

## 2. <u>ADVERTISING</u>

In application of World Sailing Regulation 20 (Advertising Code), as supplemented by the FFVoile (French Sailing Federation) advertising regulations, boats must carry the advertising chosen and supplied by the Organizing Authority (OA).

#### 2.1 Race flags

Every boat registered for the race will receive a "New Caledonia Groupama Race" race flag upon arrival at Port Moselle. This flag must be displayed in the rigging (minimum height of 1.5m above the deck) from the opening of the race village, throughout the race, and until the prize-giving ceremony.

#### 2.2 Bow stickers

The OA will provide each registered boat 2 "New Caledonia Groupama Race" stickers to be affixed to the forward quarter of the hull on both sides.





**2.3** Other sponsor markings for the race may be added. They will be indicated by an amendment to this Notice of Race.

## 3. <u>ELIGIBILITY AND REGISTRATION</u>

#### 3.1 Boat eligibility

The regatta is open to all monohulls with certified stability and multihulls. A boat shall:

- Be either a self-righting monohull or a multihull.
- Have a minimum hull length of 8m and a minimum waterline length of 7m.

Each boat shall have a fixed VHF radio that can be heard inside and outside the boat and a satellite phone with a minimum credit of 60 minutes.

The allowed classes to compete in the New Caledonia Groupama Race are as follows :

For Monohulls :	For Multihulls :	
- IRC	- Offshore Multihull Rating (OMR)	
- IRC + ORC Club	- Multi 2000 Rating	
- Cruising	- Cruising	

As well as any other category determined by the Organizing Authority, according to the interest of the participants.

In any case and under the organizing Authority, one group or class will be established if there a minimum number of registered boats in order to provide a satisfactory regatta.

Boats shall nominate which Class they are entering at time of lodging their entries in the regatta before the 10 May 2024.

Boats with an IRC and IRC + ORC Club, valid certificate for 2023. Groups are consulted on official rules of rating IRC and ORC Club.

The OA may modify, alter, amalgamate, or divide any group, may reassign boats to other groups to equalize the groups. The OA may cancel any group if fewer than 3 entries have been received by the closing date. In this case, b oats have the option to register in another group or class (if eligible) or receive a refund of the entry fees. The decision of the Race Committee is final and not subject to a request for redress. This changes RRS 62.1(a).

For boats in **IRC** and **IRC** + **ORC Club** with a valid 2023 IRC and/or ORC Club certificate and based on the criteria of the organizing authority, as well as the number of registered boats, the fleet may be divided into groups. This will be notified in the sailing instructions.

Boats in the cruising category will have the option to use the engine for propulsion.

However, they can only do so 2 hours after the start.

They shall record in a special log sheet, which is to be submitted to the OA, the time the engine was used for propulsion and the distance covered during that time.

The ranking will be based on the real time of the race and the information provided by the skipper's declaration regarding the use of the engine for propulsion and the distance covered during that time.

#### 3.2 Crew eligibility

New Caledonia Groupama Race 2024 can be raced with a full crew or in double-handed mode.

#### For full crew rankings:

- For crews of at least 3 people, the minimum age is 16 years.
- At least 30% of the crew, including the skipper, shall have completed a Sea Survival World Sailing course approved. Copies of the certificates shall be submitted at the time of registration.
- For 3 people crews, at least 2 people shall have completed a Sea Survival World Sailing course. Certificates shall be provided at the time of registration.
- At least 30% (rounded up) of the crew, including the skipper or-sailing master, shall have completed at least a category 3 race or an equivalent passage.
- At least one crew member on the boat shall have a Senior First Aid Certificate or equivalent or a higher qualification certificate. Copies of the certificates shall be submitted at the time of registration.
- Each crew member shall have a Personal Location Beacon (PLB 406) or AIS beacon worn at all time. AIS beacons are allowed only if the boat have on board an AIS receiver.
- Insurance:
  - Each skipper must be in compliance of the national authority of their country of nationality or residence.





- Each crew member residing in France must present a valid FFVoile license with a medical stamp at the time of registration.
- Foreign skippers who do not hold a FFVoile license must present the following at the time of their registration:
  - ✓ Proof of their membership in a national authority that is a member of World Sailing.
  - √ Valid third-party liability insurance for the boat with a minimum coverage of 1.5 million euros.
  - ✓ A medical certificate not less than one year old certifying individual crew members fitness to sail in this event (in English or French).

#### For double-handed race:

Competitors interested in participating in the New Caledonia Groupama Race in double-handed mode must submit to the organization a document describing their offshore sailing experience, whether in racing or cruising, and their general nautical experience.

Candidates who have not previously completed a double-handed offshore race or a similar voyage must participate in a recognized offshore race that qualifies, as determined by the OA, or complete a minimum 300-mile double-handed course (in the Groupama Race configuration) in conjunction with the OA. The OA may refuse any entry if it believes that the registration does not comply with this article.

All crew members shall be at least 18 years old.

All crew shall have completed a Sea Survival World Sailing course and hold a Senior First Aid Certificate or equivalent or a higher qualification certificate. Copies of the certificates shall be submitted at the time of registration.

- All crew shall have a Personal Location Beacon (PLB 406) or AIS beacon worn at all time. AIS beacons are allowed only if the boat have on board an AIS receiver.
- Insurance:
  - Each participant must be in compliance with the national authority of their country of nationality or residence.
  - Each crew member residing in France must present a valid FFVoile license with a medical stamp at the time of registration.
  - Foreign skippers who do not hold a FFVoile license must present the following at the time of their registration:
    - ✓ Proof of their membership in a national authority that is a member of World Sailing.
    - ✓ Valid third-party liability insurance for the boat with a minimum coverage of 1.5 million euros.
    - ✓ A medical certificate not less than one year old certifying individual crew members fitness to sail in this event (in English or French).



#### 3.3 Boat registration

Eligible boats can pre-register by completing the form at the end of this document and sending it to Cercle Nautique Calédonien.

However, the official registration will be done online through TopYacht. It must be completed by May 10, 2024.

- **3.4** Late registrations may be accepted at the discretion of the Organizing Authority.
- **3.5** Rating Request: Rating certificates must be submitted to the organization no later than May 28, 2024. No rating changes will be allowed after this date, except in the case of a protest or to correct an administrative error (from the event organization or the rating authority).
- **3.6** Groups will be established definitively by the 1st of June 2024.

## 7. COURSE

The offshore race follows the course from Nouméa, around New Caledonia counterclockwise.

Finishing in Nouméa by rounding Cape N'Dua to the south and the Grand Passage at the extreme north of the territory, with the following consecutive GPS points:

North east end of the reef: S 18° 47.74′ – E 163° 30.530′ North west end of the reef: S 19° 01.36′ – E 163° 02.360





#### **Exclusion Zone around Belep Islands**

Boats shall not cross any line between WPT1 and WPT2; WPT2 and WPT3; WPT3 and WPT4; WPT4 and WPT5; WPT5 and WPT6; WPT6 and WPT1.

GPS positions shall use the WGS84 datum described as follows:

WPT1: S 18° 47.74′ – E 163° 30.53′ WPT2: S 19° 01.36′ – E 136° 02.36′ WPT3: S 19° 32.43′ – E 163° 13.97′ WPT4: S 20° 04.61′ – E 163° 41.72′ WPT5: S 19° 48.45′ – E 164° 06.60′ WPT6: S 19° 09.82′ – E 163° 48.66′

The race will start toward Amédée Lighthouse with two marks and Amédée Island to port, then around Cape N'Dua to port.

The GPS coordinates for the markers and islands are as follows :


Basse Thibée: S 22° 26.83′ – E 166° 29.95′ Basse Amédée: S 22° 28.59′ – E 166° 27.34′

## South of Ouen Island : Nokoué Passage and Exclusion Zone

Navigation in the Nokoué Channel (along the south of Ouen Island) is prohibited.

Boats shall not cross any line WPT7 and WPT8; WPT8 and WPT9; WPT9 and WPT10; WPT10 and WPT11; WPT11 and WPT7.

GPS positions shall use the WGS84 datum described as follows:

WPT7: S 22° 50.220′ – E 166° 52.561′ WPT8: S 22° 50.219′ – E 167° 00.006′ WPT9: S 22° 42.000′ – E 167° 01.417′ WPT10: S 22° 28.639′ – E 166° 52.744′ WPT11: S 22° 34.697′ – E 166°46.423′

## 8. RANKINGS AND PRIZES

#### Rankings for both crews and double-handed:

- ✓ Winner of the New Caledonia Groupama Race Main Trophy IRC (All monohull classes)
- ✓ Monohull Line Honors (elapsed time)
- ✓ Multihull Line Honors (elapsed time)
- ✓ Monohull IRC Offshore by group
- ✓ Monohull ORC Club all classes by group
- ✓ Multihull Multi 2000 Offshore by group
- ✓ Monohull Cruising Class
- ✓ Multihull Cruising Class

Trophies will be awarded if there are at least 3 participants in each category.





If there are two boats or fewer in a group, no prize will be awarded.

If there are three to five boats in a group, only the first prize will be awarded.

If there are six boats or more in a group, the first, second, and third prizes will be awarded.

## 9. MEDIA, IMAGES AND SOUND

All boats shall be equipped with Iridium satellite communications (satellite phone). Communications between boats will be permitted at hours stated in the Sailing Instructions. You shall send a daily video (30 to 90 seconds) and 5 photos per day on board. The Organizing Authority will provide a SIM card for that.

## IO. CHANGES TO CLASS AND RACING RULES

#### 10.1 IRC Rules

IRC rule 11.2 & 21.6.1: a boat in the IRC Handicap Category may carry one more spinnaker than shown on the boat's IRC Certificate without an increase of rating.

IRC rule 22.4: the maximum total weight of crew in kilograms that may sail aboard a boat shall not exceed the crew number printed on the boat's IRC Certificate multiplied by 87,5.

#### 10.2 ORC Club Rules

A boat that is also entered in the ORC Club division may carry the maximum number of spinnakers allowed under its IRC certificate plus the additional spinnaker allowed under IRC rule 11.2 and 21.6.1.

#### 10.3 RRS (Racing Rules of Sailing)

RRS 42: A boat in the Cruising Division may use its engine for propulsion two hours after the start but must stop it prior the finish. The number of engine hours and the number of miles traveled shall be logged on the log book and forwarded to the organization.

#### 10.4 Automatic Steering Devices

The autopilot is allowed in compass mode as well as wind mode (this-changes RRS 52 and IRC Rule 15).





## II. DISCLAIMER OF LIABILITY

Competitors participate in the race **entirely at their own risk** (see RRS 4, Decision to Race). The organizing authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

## **12.INSURANCE**

Each participating boat shall have valid third-party liability insurance with a minimum cover of 1.5 million Euros or its equivalent for the event.

## **IB. FURTHER INFORMATION**

World Sailing safety courses will be held in 2024 and open to all New Caledonia Groupama Race participants.

Specific dates will be communicated by the Cercle Nautique Calédonien later.

There are also races Sydney to Nouméa (organized by the CYCA) and Auckland to Nouméa (organized by the RAYC).

The departures for these races will take place on Saturday, May 25, 2024, with prize-giving ceremonies on Saturday, June 1 at the Cercle Nautique Calédonien.
